BUDGET PLAN AGREEMENT

Budget Plan (with approved credit):

This payment option is only available with an approved credit application.

- A Budget Plan price per gallon and your estimated gallons (including tax) will be calculated into equal monthly payments. Payments begin in August. The following July will be the true-up month. A budget recalculation will be performed mid-January.
- A statement is sent at the beginning of each month, showing the budget amount due.
- Customers wishing to continue in the Budget Plan in subsequent years will receive a new Budget Plan Agreement annually, which will contain any change in the monthly rate.
- Budget Plan customers are automatically placed on and must remain on Auto-Fill
- Payment is due by the 20th of each month. **You will be removed from the Budget Plan program for late payment, and a finance charge will be added to the outstanding balance. Your account will then be on a Will-Call delivery status.**
- The Budget Plan monthly payments may be made using Automatic Bill Payment by completing the credit card or e-check information below.
- Monthly Budget payments may also be paid online at www.nwohiopropane.com or the NWOP App.
